## **AUGUST 7, 2007**

Minutes of the Regular Meeting of the Board of Education of Morton Unit School District 709 held August 7, 2007, at the District Office.

#### **REGULAR MEETING -**

## Call to Order and Roll Call -

President Linda Menold called the regular meeting to order at 8:10 p.m.

## Pledge of Allegiance -

The Board of Education recited the Pledge of Allegiance.

## **Audience Presentations –**

There were no audience presentations.

#### Reports -

#### <u>Administrative</u> –

#### Jr. High School Color Change -

Dr. Kilpatrick reported that the Jr. High Administrators have requested that the green and white school colors be changed to the high school colors, cherry and gray. They suggested the change would re-energize spirit at the Jr. High and it may be cost effective for parents buying clothing for Jr. High students that would transition easily into the high school. The administrators recommend changing the uniforms over a period of time as they come due for replacement. After discussion, it was suggested that comments be heard from the public on the issue before making the change.

#### <u>Jackon Street Changes -</u>

Dr. Kilpatrick distributed a letter he delivered to the Village Board the evening before. The letter was in response to changes the Village and IDOT have planned for Jackson Street by adding a center turn lane from Main Street to Kansas Ave. The Village agreed to end the turn lane at Indiana Ave. and to modify the turn lane to 12 feet to keep the traffic further from the sidewalk. A crosswalk will be added on Jackson by the High School in the future after review by the high school staff.

Mrs. Menold thanked Dr. Kilpatrick for working with the Village on this matter.

## **Current Employment Data –**

Mr. Smock distributed and reviewed an analysis of applicants and the District's hiring practices. He noted that of the 28 certified positions filled for the coming school year, 15 are non-residents of Morton, with 13 being residents. He also noted that 5 of those hired were graduates of Morton High School.

Mrs. Menold thanked Mr. Smock for the time taken to gather the information.

## Village Comprehensive Planning Committee Update -

Dr. Kilpatrick reported that the Village has formed a Comprehensive Planning Committee. He along with Mrs. Menold, Mr. Rassi and other staff members are part of the education sub-committee and will be looking at the education system's needs over the next 10-20 year time period. The sub-committee will focus on facilities, communication and curriculum. They plan to use the results of the survey that the school district will conduct this fall. Dr. Kilpatrick will give periodic updates to the Board.

## **Board Committees –**

#### **Policy Committee -**

Mrs. Menold reported that Vickie Foster has been working on updating the Policy Manual. She hopes to have it completed by the end of this school year. She noted that the Administrative Procedures will be split from the policies and placed in a separate manual.

### **Proposed Resolution –**

Mrs. Menold reported that Dr. Kilpatrick recently presented the proposed resolution for funding for "Exceptionally Talented Children" (formerly Gifted Program) to the ISBE committee. The resolution was co-sponsored by Morton, Dunlap and District 150. The committee unanimously approved the resolution to be taken to the full membership in the fall. If it is approved by the full membership, the resolution will then be taken to the State Legislature.

#### **Ends Policies -**

Mrs. Menold reviewed and noted individual policies that have been revised. She asked the Board to review the changes carefully, as these polices are the foundation of how the Board and District conduct "business." The Ends Policies will be brought back to the Board for the First Reading on August 21.

## Approve Assistant Cross Country Coach Position –

Dr. Kilpatrick noted that at an earlier meeting the administration discussed the need for an assistant cross country coach position. He explained that the growing number of participants along with safety issues necessitates the need for this additional position.

Motion by Mrs. Overcash, second by Mr. Applen that the Board of Education approve the addition of the position of assistant cross country coach for the 2007-2008 school year. Roll Call Vote: Yea 6 Nay 0 Motion carried. **Approve Board Committee Assignments -**Dr. Kilpatrick noted that the Board Committee assignments were included in the folders distributed this evening. The Building and Grounds committee will meet as a committee of the whole. It was suggested that if a committee member is unable to attend a meeting, they notify others for a possible replacement.
