DIAGNOSIS: Found faulty fan cycle control.

ACTION/REMEDY: Made trip for parts. Replaced fan cycle control, high PSI cut-out, direr. Pressure tested unit. Evacuated refrigeration and recharged to factory specifications. Observe ice drip at 14 minutes freeze, 140 harvest.

COMMENTS/RECOMMENDATIONS: Unit is functioning properly.
