Call to Order and Roll Call –

Freedom of Information Requests –

Dr. Hill reported there are no Freedom of Information requests to report.

External Counseling Report -

Dr. Hill reported on the early intervention provided by Illini Family Counseling to MHS students and families. A summary of contacts made with students throughout the school year was provided. The report includes number of students served by semester and types of issues encountered.

Legislative Update –

Dr. Hill noted new or pending state legislation that impacts school districts including financial, curricular, and student safety issues.

Security Audit –

Dr. Hill updated the board on the progress to secure a firm to conduct a security audit on all buildings in the district. Three firms that oversee this type of audit are currently being considered. They will assess the exterior and interior of all buildings and the district's crisis plan. The process takes a month to complete and ideally would take place when students are in attendance. The auditing firm would partner with local law enforcement during the assessment.
